NOTES

- It is a criminal offence to fail to notify the Monitoring Officer of any Disclosable Pecuniary Interests. It is also a criminal offence to knowingly provide information that is false or misleading or being reckless as to whether the information is true and not misleading.
- The Glossary at the back of the form provides definitions from the Relevant Authorities (Disclosable Pecuniary Interests) Regulations 2012. These Regulations specify what constitutes Disclosable Pecuniary Interests.
- If you consider that the disclosure of the details of any of your interest(s) could lead to you, or a person connected with you, being subject to violence or intimidation, and you would like these details withheld from the public register of interests please complete Part 3. If the Monitoring Officer agrees that your interest(s) constitutes a sensitive interest for the purposes of section 32 of the Localism Act 2011, the information will be recorded but the copy of the register made available for public inspection will specify that an interest has been disclosed but is withheld under Section 32 of the Localism Act and with the agreement of the Monitoring Officer.

Any employment, office, trade, profession or vocation carried on for profit or gain.

2. Sponsorship

Any payment or provision of any other financial benefit (other than from the relevant authority) made or provided within the relevant period in respect of any expenses incurred by M in carrying out duties as a member, or towards the election expenses of M.

This includes any payment or financial benefit from a trade union within the meaning of the Trade Union and Labour Relations (Consolidation) Act 1992.

You should detail the name and address of any person or body who has made a payment to you in respect of your election expenses or in carrying out your duties as a councillor.

3. Contracts

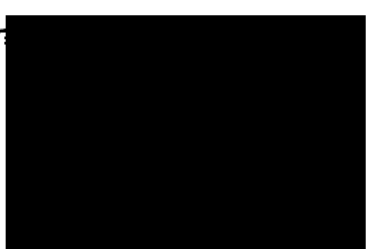

4. Land

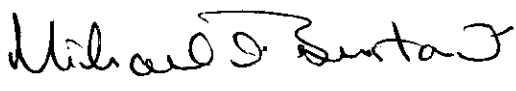
