NOTES

If the Monitoring Officer agrees that your interest(s) constitutes a sensitive interest for the purposes of section 32 of the Localism Act 2011, the information will be recorded but the copy of the register made available for public inspection will specify that an interest has been disclosed but is withheld under Section 32 of the Localism Act and with the agreement of the Monitoring Officer.

2. Sponsorship

You should detail the name and address of any company or other body in which you or your partner have a shareholding of more than £25,000 (face value) or have a stake of more than 1/100th of the total issued share capital (whichever is the lower) which to your knowledge has a place of business in the area of the Council named above.


