P.695 URGENT ITEMS SDNP/25/00065/HOUS (Longview Michel Dene Rd – Approved by SDNP) Residents have approached councillors with complaints regarding this development which include the height of the elevations. The Parish council had objected on the following grounds:

a. Impact on Character and Appearance The proposed development is considered detrimental to the character, heritage, or visual amenity of the area through overdevelopment right up to the boundary b. Traffic and Safety Issues The development could cause significant access problems and or pose safety risks, due to its close proximity to the pavement and lack of parking/turning space, hindering sightlines, and endangering footpath and road users. Should the above issues be resolved, the Council would be minded to approve and there are many positive design features that improve upon the visual appearance of the property.

Whilst the applicant has planning approval, councillors felt that a meeting should be arranged with the planning officer to express concerns regarding safety and other issues. *Action: Clerk to approach planning officer*
