The meeting was called to review the provision of additional Yellow Lines around the Villages of East Dean and Friston, an issue which has been on the Agenda for some 3 or 4 years:

- Gilberts Drive/ Lower Street Junction The junction was inspected and it
 was agreed that lines should be provided opposite the lower street exit
 onto Gilberts Drive as well as to both sides of Lower Street where it exits
 onto Gilberts Drive in order to keep the junction clear and avoid
 congestion. Parish Clerk to confirm to Jo Reed the extent of the
 Conservation Area as this will affect the type and colour of yellow lines
 applied. [Map of Conservation Area sent 18/08/2017]
- Thai Terre The area was inspected and due to the narrowing of the road at the Thai restaurant it was agreed to extend the existing yellow lines to the door of the Thai Terre restaurant. This area is inside the Conservation Area.
- Upper Street/Bowls Club Again the area was inspected and in order to maintain traffic flows it was agreed to apply yellow lines opposite the bowls club exit and also along the narrow road section adjacent to the

- holiday cottages all the way to the A259 junction. Again, inside the Conservation Area.
- Upper Street Drainage The drainage issue was inspected and it was suggested that if the vegetation was cleared on the West side of Upper Street this might allow the water draining from Friston Hill to enter the 2 drains. Cllr Seeley to liaise with Tom Lee from ESCC who attends the SLR meetings. [Online report logged under Ref: 00146563]
- Micheldene Road Junction/A259 The issue of illegally parked cars on the verge at Micheldene was reviewed and it was agreed to place yellow lines from the junction on both sides of Micheldene back to the end of speed restriction signs. Cllr Seeley to apply through PC for a license to place concrete planters on the roadside to prevent parking at the junction.
- Friston Church Slip Road The situation was reviewed in detail and it was
 agreed that no parking restrictions should be applied to the slip road as
 there was still the junction of Crowlink Lane with the A259 allowing access
 to Crowlink. It was agreed to seek permission from the Church to place
 No Parking signs on the flint wall along the slip road which would act as a
 deterrent. No further action required.

ESCC confirmed that on receipt of details of the Conservation Area from the Clerk the consultation period on additional yellow lines would commence and drawings of the proposals above would be issued to the Parish Council for comment/approval before being advertised to residents. [Note: this information was supplied on 18/08/2017 and a response is awaited].
