• To consider the offer of free trees from the Woodland Trust – The following email message was received from the Woodland Trust:

"We want to make sure everybody has the chance to plant a tree, so we're still giving away hundreds of thousands of them every year. Together, we'll get millions more trees in the ground in our quest to hit the UK's carbon net-zero target.

We are currently accepting applications for free trees from local councils, town councils and parish councils, as well as from schools and community groups in their area, and we would like to ask for your support in getting the message out.

Eligible groups can apply for up to 420 free saplings per application window, with our deliveries taking place every year in March and November. Applications processed now will receive their saplings in March 2024, just in time for planting season!" A change in the timetable of Bus 41 – (Email received from Cuckmere Buses) For your info, our winter bus timetable starts on 31 October. As the ED&FPC kindly support service 41, I wanted to let you know in advance of a minor change to this Village service. From Tuesday 31 October the mid-day journey will operate 15 minutes later than currently. This

Outstanding Items from the meeting on the 5<sup>th</sup> of October

- **To request a meeting with the National Trust** Following on from the meeting on the 5<sup>th</sup> of October, the Parish Clerk contacted the National Trust. They have refused a face-to-face meeting and would prefer to deal with the Council via a telephone conversation as the Ranger Team is not based in Birling Gap. It was subsequently suggested to them that members of the Parish council would be willing to meet them at their offices in Brighton. This has now been escalated to the Head Ranger and an email has been sent.
- **PSPO and Wealden Council** Following the meeting on the 5<sup>th</sup> of October, the Parish clerk have written to Wealden District Council but yet to receive a response from them National
